PLEASE REVIEW THE INFORMATION ON BOTH SIDES OF THIS APPLICATION

The CRSU Older Girl Destination is a portion of the Crossroads Service Unit budget designed to assist CRSU registered Girl Scouts financially so that they may participate in Older Girl Destination Trips. Please note: Older Girl Destination Trip Funds are very limited.

- Adults are not eligible for Older Girl Destination Funds.
- The Older Girl Destination application can be found at <http://www.crossroadsgirlscouts.com> or from the CRSU Treasurer.
- The Older Girl Destination application must be completed in its entirety, and signed or it may be rejected.
- Only currently registered Girl Scouts in the CRSU are eligible to apply and receive CRSU Older Girl Destination Funds.
- Currently registered Girl Scouts in the CRSU may apply and potentially receive Older Girl Destination Funds to cover a portion of the fee. The amount each girl receives is dependent upon how many CRSU Girl Scouts apply and the amount in the CRSU budget for the fiscal year.
- The CRSU Older Girl Destination Fund application should be submitted to the CRSU Treasurer or the CRSU Leader Support Manager. No later than April 30th of the calendar year.
- CRSU Older Girl Destination Fund requests do not automatically register the applicant for the event.
- CRSU Older Girl Destination Fund applications will be reviewed by two CRSU team members for approval.
- To be eligible to receive CRSU Older Girl Destination Funds, the Girl Scout (and/or her Troop) must have participated or plans to participate in at least one product sales program (Fall Sales or Cookie Sales) during the fiscal year in which they are applying for Friendship Funds, unless they were not a registered Girl Scout during product sales time.
- The Girl Scout's most recent troop TFR has been turned in to the CRSU Treasurer.
- CRSU will make every effort to provide scholarships to those that request it; however, Friendship Fund monies are limited.
